UPON hearing the counsel the Court made the following
O R D E R

IA No. 164225/2019:

Having heard Mr. Arvind Datar, learned Senior Advocate, for sometime on behalf of the MIDC, we find that a sum of Rs. 18 crores which should have been contributed by 324 out of 900 units which operate in this area has not been made.

The MIDC may issue notice to each of these 324 units within a period of one week from today indicating what is their share of contribution. The units are thereafter given a period of three weeks within which to pay the amounts that are stated in these notices. If within this period, the units do not pay the entire contribution amount or default in making the same, the MIDC will be at liberty to move against them in accordance with law. The MIDC may, in the event of non-payment by any such units, move the PCB in order to discontinue water supply for the defaulting units.

In the meanwhile, no prosecution or other action be taken against any of the MIDC officials.

I.A. stands disposed of accordingly.
